Planned Account Withdrawals

Helping the animals just got easier.

We know you want to help the animals and support the programs of the Humane Society of the Tennessee Valley and that you expect us to use your contribution effectively without waste. We also know convenience is a premium in your busy world.

We would like to invite to participate in our PAWs program available to Society supporters. PAWs is an automatic account debit program managed for us by Home Federal.

Why You Should Use PAWs:

Convenience: PAWs makes it easier to support the work of the Society.

Cash Management: Instead of writing one or two larger checks during the year, you can make a smaller monthly gift.

Efficiency: HSTV can spend less on solicitation mailings and membership renewals. PAWs participants can elect not to be sent any mailings.

Simplified Record Keeping: Your contribution will now be a part of your monthly banking statements, not scattered through piles of canceled checks or check registers.

For the animal's sake: The goal of this program is to increase funding for our programs. If a current supporter now contributes \$75 a year, authorizing \$8 monthly through PAWs will increase that amount by 25 percent.

PAWs is a winning combination for our donors and our animals. Remember, you choose the monthly gift that is most comfortable for you. And, of course, you can cancel your participation at any time by notifying the Humane Society of the Tennessee Valley. Try PAWs and see if you don't think it's a great way to give.

How it Works:

When you send in the authorization form printed below, you enable the Society, under the supervision of Home Federal, to debit a specified amount each month from the checking or savings account you've designated. That amount is then credited to the Humane Society of the Tennessee Valley's account. No checks for you to write, envelopes to address or stamps to buy.

Fill out the Authorization Agreement and mail it to the Humane Society of the Tennessee Valley in the enclosed envelope
